## ***Facilities Update:***



The dorm modernization is a two phase project which began in fall 2013. Phase 1 constitutes 70% of the project and phase 2 constituting the remaining 30% of the total project.

As of March 1, Phase 1 is about 50% complete with an estimated completion date of May 30<sup>th</sup>. Phase 2 is scheduled to begin June 1<sup>st</sup> and be completed by end of September.

## ***Student Services Updates:***

### ***Priority Registration Starts May 5<sup>th</sup>!***

Priority registration for summer and fall will begin on Monday, May 5<sup>th</sup> along with the implementation of the new enrollment priorities. Students will be required to complete an admissions update prior to registration. Registration dates and times for each student will be automatically assigned by the system approximately 2 weeks before registration. The system will compute registration dates and times based upon variables associated with point values, and then will sort by student ID number. Registration dates and times will be distributed over the number of days allotted for a particular group with priority assigned from the highest points down to the lowest. No priority group or student will be assigned a registration date or time in which the college is closed (i.e., after 4:00 p.m. or on weekends). Students can view their registration date and time via Cougar Tracks. Students may enter the registration system anytime beginning on or after their assigned registration date and time. If students miss their date and time, they may simply log into their student account via Cougar Tracks and register thereafter.

### ***Taft College Alumni awarded Student Athletic Achievement Award by CCCAA***

The California Community Colleges Academic Advisors/Counselors for Athletes (3C4A) annually sponsors two Student Athlete Achievement Awards. The awards are presented at the California Community College Athletic Association Spring Convention. Our very own Tony Thompson is the Vice-President of the North section of the 3C4A.



The criteria for the Student Athlete Achievement Award includes, but is not limited to, athletes who have overcome some significant obstacle(s) that made going to college and participating in athletics very difficult, and yet they did so. In conjunction with her Volleyball coach, Kanoe Bandy, Athletic Advisor Tony Thompson nominated Onolina Taotofi to the selection committee, which reviews the nominations and makes their selections. Onolina played volleyball at Taft College from 2011-2013 before transferring to Southwest Baptist University in Bolivar, Missouri. She overcame great adversity in high school on the island of Oahu before entering Taft College as a member of the Women's Volleyball team. During her time here, Onolina demonstrated her determination to succeed on the court and in the classroom. Geoff Dyer was instrumental in encouraging Onolina to pursue her dreams. Through the support of Tony, Kanoe, and Geoff, Onolina has become a role model to many who face challenges in high school before realizing their dreams in college.

## ***Launch of Student Success Committee:***

## ***Instruction Updates:***

### ***Scholarly Research on TIL Program is Published!***



Congratulations to Jeff Ross, Jamia Marcell and Paula Williams, along with Dawn Carlson from the Virginia Commonwealth University, for their recent article published in the Journal of Postsecondary Education and Disability,

Volume 26 (4), Winter 2013. This special issue of the Journal focused on postsecondary education for students' intellectual disability. The article reported the study on employment and independent living outcomes of 125 graduates from the Taft College Transition to Independent Living (TIL) Program. The study findings suggest that graduates of the TIL program enjoy employment and independent living outcomes which exceed the rates observed in the general population of person with intellectual and developmental disabilities (see Journal of Postsecondary Education and Disability, Volume 26 (4), Winter 2013, page 337). ### ***Educational Master Plan Update:***

Last fall, the District launched the development of an Educational Master Plan which will guide and inform the District over the next 10 years. An Educational Master Plan Committee was formed representing faculty, classified staff, managers and educational administrators. This team has worked closely with consultants John Spevak and Dan Rosenberg from the College Brain Trust in developing the plan. In November, the campus community participated in a campus-wide survey to gather data about matters of importance to the District. In December, on-campus interviews were conducted with a wide variety of faculty and staff. Throughout this period, the Institutional Research, Assessment and Planning department prepared an extensive report reflecting internal and external conditions facing the District. And in February, the EMP Committee participated in a day-long retreat to draft planning assumptions and preliminary goals --- key components of the final plan.

### ***Accreditation Update:***

About this time last year, we began developing our plans for the 2015 Accrediting Commission for Community and Junior Colleges (ACCJC) Self-Evaluation and Comprehensive Site Visit. Accreditation is a college-wide effort and provides an opportunity to examine our institutional effectiveness with the goal of continual improvement. We formed our Self-Study teams and Accreditation Steering Committee. At the start of this academic year, the teams got to work – first developing an outline for their assigned standard and then beginning to write their portion of the Self-Evaluation.

We are making good progress and anticipate each team will have a rough draft of their standard by the end of this academic year. Next year we will review, refine and finalize our draft. The final copy of the Self-Evaluation will be mailed to the Commission in Summer 2015. The visiting team will visit the campus sometime in October 2015.



### ***Dr. John Eigenauer Presentation at the National Institute of Staff and Organizational Development (NISOD)***

Dr. John Eigenauer, recipient of the NISOD Teaching Excellence Award in 2007, will be presenting at the 2014 NISOD International Conference on Teaching and Leadership Excellence in Austin, Texas. The title of Dr. Eigenauer's presentation is *"Teaching Students to BE Critical Thinkers."* NISOD is a consortium of community and technical colleges that share a philosophical commitment to support excellence in teaching, learning and leadership. NISOD draws thousands of attendees to its conferences.

Closer to home, Dr. Eigenauer will also be speaking the CSUB Department of Philosophy and Religious Studies March Colloquium on March 7 from 3:30 – 5:00 p.m. on the CSUB campus.
